## 注 1 Note 1:

- 〇:表示该有害物质在该部件所有均质材料中的含量均不超出电器电子产品有害物质限制使用国家标准要求。
  - Indicates that the concentration of the hazardous substance in all homogeneous materials in the parts does not exceed the national standard requirements for the use of hazardous substances in electrical and electronic products.
- ×:表示该有害物质至少在该部件的某一均质材料中的含量超出电器电子产品有害物质限制使用国家标准要求。
  Indicates that the concentration of the hazardous substance of at least one of all homogeneous materials in the parts exceeds the national standard requirements for the use of hazardous substances in electrical and electronic products.
